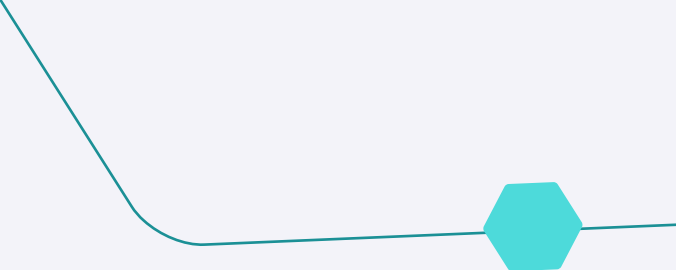

## INTRODUCTION

---

As a nonprofit organization, Lincoln Learning Solutions is all about partnering with schools and communities. This guide reviews key federal funding proposals for the 2024–2025 school year alongside other important resources. In response to the pandemic, Congress stepped up with a massive \$190 billion to help schools address challenges like learning loss, frequent absences, and mental health concerns.

## BACKGROUND

---

Public K-12 schools are funded by local, state, and federal dollars, with the split varying by location. Most states have their budgets ready for the fiscal year starting July 1, 2024, and together with local governments, provide about 86% of school funding. The federal fiscal year starts on October 1, 2024, and following last year's debt ceiling agreement, the Administration has proposed a budget that includes education funding within those limits. Congress is still working through the budget process, and final decisions are pending.

## EMERGENCY RELIEF – ARP ESSER III

---

The American Rescue Plan mandates that states allocate their ESSER III funds by September 2024. Once allocated, the funds can be extended until December of the same year or March 2026. These funds are available for services like tutoring, extended learning time, and summer programs.

**The following dates are crucial to guarantee access to these funds.**

- **December 31, 2024**, is the final date for submitting federal liquidation extension requests for ARP ESSER III funds. This ensures that any remaining funds are fully liquidated.
- **January 28, 2025**, is the final liquidation date for funds if an extension is not granted. Contracts must be obligated by September 30, 2024.
- **March 28, 2026**, is the final liquidation date for funds if granted a liquidation extension.

# ELEMENTARY AND SECONDARY EDUCATION ACT FUNDING

## Boosting Basic Programs by Local Educational Agencies (Title I, Part A)

Title I, Part A under the ESEA focuses on ensuring every child gets a fair, equitable, and high-quality education, centering on narrowing the educational achievement gaps, as stated by the U.S. Department of Education. It offers financial support to local educational agencies (LEAs) and schools with many children from low-income families, helping them to achieve rigorous academic standards. The financial aid a school receives is directly linked to the number of low-income students it serves.

## Individuals with Disabilities Education Act (IDEA)

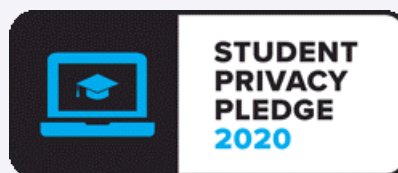
IDEA earmarks federal funds to guarantee that students with disabilities receive Free Appropriate Public Education. It supports states and local school districts in safeguarding the rights and meeting the unique needs of infants, toddlers, children, and youths with disabilities and their families. This year's budget proposes \$14.4 billion for IDEA, marking a \$200 million increase from the previous year.
